



Lasare Ltd. Handling Tariffs in Georgian Lari – effective from 1 September, 2025

Cargo Terminal Handling Tariffs:

1. Aircraft Cargo Handling

Outgoing/incoming/ transit cargo/mail/ handling at the aircraft, documentation supervision:

– up to 50kg	– 15.00
– from 50kg	– 0.30 per kg

note: As agreed with the carrier air company only.

2. Outgoing/incoming and transit Heavy Cargo Handling:

0.04 per kg

note: 1 place + 150kg.

3. Terminal Cargo Handling

3.1. Incoming/outgoing/transit air or land cargo/mail /courier parcel handling upon receipt or delivery:

– up to 50kg.	– 16.00
– from 50kg.	– 0.32 per kg

note: As agreed with the carrier Air Company only.

3.2. Outgoing/transit air cargo/mail expedited:

– up to 50kg.	– 3.00
– from 50kg.	– 0.06 per kg

note: The service adds to paragraph 3.1.

3.3. According to the request of the Customer incoming/transit air cargo/courier parcel handling repeated unloading/loading from the vehicle of:

- up to 500 kg. _ 6.00
- from 500 kg. _ 0.12

4. All-in-one terminal service for hand luggage/parcel:

- up to **50kg.** - **25.00**
- from **50kg.** - **0.50** per kg

note: When hand luggage/parcel is taken by consignee from the terminal. All in One terminal service includes paragraphs 3.1; 11.1; 17.3.

5. Valuable cargo All in One terminal service :

(If the armored vehicle is ensured by the Bank)

- up to **50kg.** - **40.00**
- from **50kg.** - **0.80** per kg

note: All-in-one terminal service includes paragraphs 1; 3; 17.3.

6. Courier Parcel Handling :

6.1. If the courier parcel is submitted by the customs expertise department within the cargo terminal territory:

- up to **50kg.** - **12.00**
- from **50kg.** - **0.24** per kg

6.2. All in one terminal service:

If the courier parcel is submitted by the parcel carrier to the customs expertise department within the cargo terminal territory by sealed vehicles:

- up to **50kg.** - **17.00**
- from **50kg.** - **0.34** per kg

note: All-in-one terminal service includes paragraphs 1; 3; 17.3.

7. Warehouse operation:

Cargo / hand luggage handling at the Customs Warehouse under proper Customs Declaration :

- up to 50kg. - 9.00
- from 50kg. - 0.18 per kg

note: Used while warehoused cargo or part of the cargo pick up from the warehouse.

8. Customs Warehouse Operations:

*) – The day of cargo receive is the day of incoming cargo arrival or outgoing cargo receiving

**) – The first day of cargo storage is the day of its receive.

8.1. Incoming air cargo/mail storage at the Temporary Storage:

1) 24-hours from the 1st (first) day:

- up to 50kg. - 0.50
- from 50kg. - 0.01 per kg

2) 24-hours from the 3rd (third) day :

- up to 50kg. - 5.00
- from 50kg. - 0.10 per kg

note: In case of storage under special conditions, proper storage tariffs are effective.

8.2. Cargo storage in customs warehouse:

- 24-hours from the 1st (first) day
- up to 50kg - 5.00
- from 50kg - 0.10 per kg.

note: a) The new calculation of the storage cost up to 50 kg starts from the day of removal of each part of the cargo stored in the customs warehouse.

b) In the case of special conditional storage, the storage fee specified for the respective condition applies.

8.3. Outgoing/incoming /transit cargo in Customs Warehouse valuable air cargo storage:

8.3.1. 24-hours from the 1st (first) day: - 50% from the storage tariff

8.3.2. per each following 24-hours

- up to 50kg	- 75.00
- from 50kg	- 1.50 per kg

note: a) The new calculation of the storage cost up to 50 kg starts from the day of removal of each part of the cargo stored in the customs warehouse.

8.4. Outgoing/incoming /transit or warehoused in Customs Warehouse dangerous air cargo storage :

24-hours from the 1st (first) day: - 50% from the storage tariff

- up to 50kg	- 11.00
- from 50kg	- 0.22 per kg

note: a) The new calculation of the storage cost up to 50 kg starts from the day of removal of each part of the cargo stored in the customs warehouse.

8.5. Outgoing/incoming radioactive substances (cargo) storage :

24-hours from the 1st (first) day:

- up to 50kg.	- 30.00
- from 50kg.	- 0.60 per kg

8.6. Outgoing/incoming/transit or warehoused in Customs Warehouse air cargo storage that needs special (temperature) storage conditions:

8.6.1. +2°C +8°C; -2°C -8°C or -18°C -20°C or +15°C +25°C temperature regime - 24-hours from the 1st (first) day: **- 50% from the storage tariff**

8.6.2. +2°C +8°C; -2°C -8°C or -18°C -20°C temperature regime per each following 24-hours:

- up to 50kg	- 20.00
- from 50kg	- 0.40 per kg

8.6.3. +15°C +25°C temperature regime per each following 24-hours:

- up to **50kg** - **18.00**
- from **50kg** - **0.36** per kg

note: a) The new calculation of the storage cost up to 50 kg starts from the day of removal of each part of the cargo stored in the customs warehouse.

8.7. Outgoing cargo/mail/courier parcel storage that is under registration process and needs proper storage period

8.7.1. 24-hours from the 1st (first) day:

- per AWB - **6.00**

8.7.2. from **3th** day during overnight:

- up to **50kg** - **6.00**
- from **50kg** - **0.12** per kg

note: a) Storage calculation is made before the date of the cargo / mail flight booking

b) In case of special conditional storage, the storage tax specified for the relevant condition shall be applied.

8.8. Outgoing HAWB / Parcel storage:

24-hours from the 1st (first) day:

- up to **50kg** - **6.00**
- from **50kg** - **0.12** per kg

note: a) Prior to MAWB complete.

b) In case of special conditional storage, the storage tax specified for the relevant condition shall be applied.

8.9. Hand luggage:

24-hours from the 1st (first) day:

- up to **50kg** - **4.00**
- from **50kg** - **0.08** per kg

9. Parking within Registration Control Zone - one truck:

- per truck - 50.00 per overnight
- per truck – trailer - 80.00 per overnight

note: For sealed vehicles under customs control entering the zone for further cargo transportation, or reloading to the consignee's vehicle according to the specification of the cargo.

10. Incoming cargo service – human remains (1/200): - free of charge

11. Registration:

11.1. Incoming /transit air cargo/mail:

- one set of documentation - 30.00

11.2. Loaded truck:

- one set of documentation - 30.00

11.3. Cargo/mail to be sent by Cargo Agents of a/c:

- one set of documentation - 30.00

11.4. Outgoing HAWB or parcel:

- note: In case of outgoing MAWB complete. - 30.00

11.5. Request on cargo warehousing at Customs Warehouse:

- one pack of documentation registration - 20.00

note: In case of primary warehousing of the cargo.

12. Incoming (import)/outgoing (export) cargo/mail/hand luggage transportation service:

12.1. Within & out of Tbilisi not further than 20km:

- one track - 180.00
- One truck with temperature control -250.00

12.2. Within territory of airport:

- one truck - 80.00
- one truck with temperature control - 120.00

note: paragraph 12.2. is used for costumed cargo/mail inside delivery within internal territory of airport or between terminals and outside the Airport no more than 5 kilometers.

12.4. Truck standing idle

- Truck standing idle for unforeseen reasons

Per each calendar day **- 60% of the delivery price**

13. off-loading or loading to the truck at the point of destination:

13.1. Off-loading from the truck or loading on the truck:

- up to 500 kg – 100.00
- from 500 kg – 0.20 per kg

13.2. Additional services:

13.2.1. Lifting up/down (one floor)

- up to 500kg – 50.00
- from 500kg – 0.10 per kg

13.2.2. Unpacking, removal of debris etc.

- up to 500kg - 100.00
- from 500kg – 0.20 per kg

Note: The weight of the cargo is calculated from the weight indicated in the transport documentation.

14. Lease/rent (airport territory only):

14.1. Rent of cargo vehicle, loader or transporter :

- per **an (one)** hour **- 250.00**

14.2. Rent of car or minibus:

- per **an (one)** hour **- 100.00**

- from **50kg** - **0.22** per kg

19. Dangerous and radioactive cargo handling:

- 1) Dangerous cargo handling (one AWB) - **100.00**
- 2) Radioactive cargo handling (one AWB) - **120.00**

note: Used regardless of storage conditions.

20. Preparing/complete of cargo AWB:

- 1) One set of cargo MAWB - **30.00**
- 2) One set of cargo HAWB - **30.00**

21. Preparation of dangerous goods declaration or/and checking:

- 1) One declaration - **160.00**
- 2) Dangerous goods packing checking and proper documentation processing - **140.00**

22. Outgoing Live Animals handling:

- Preparation, processing and checking of documentation necessary for live animals sending (per AWB) - **200.00**

23. Outgoing cargo/mail/courier parcel repeat terminal service:

In the case of repeated export services as a result of adjusting the content by the sender of the already packaged and ready for sending cargo/mail - **50% of services rendered**

note: Terminal service includes paragraphs 2; 3; 15; 17.1 or 17.2

24. Commissions of "Charges collect" (CC):

Freight Commission - 5%, min.

25.1.1. Electronic Documentation scanning and e-mail sending - 10.00

25.1.2. Copy receiving/printing (one page) - 0.25

Glossary of Terms

- **Cargo** - Any commercial or other material consignment that does not fall under postal regulations is subject to customs control and declaration and is transported under an MAWB/HAWB (air transport) or CMR (road transport).
- **Mail** - A consolidated batch of consignments dispatched or received through the national postal operator (Georgian Post) in accordance with UPU regulations.
- **Courier parcel** - A consolidated batch of consignments dispatched or received through a private postal operator/carrier, not subject to customs declaration. Transported under MAWB/HAWB or CMR, accompanied by a postal consignment list submitted to customs.
- **Parcel** - A cargo containing any commercial or other material item that due to its value, type, destination or other characteristics must be declared in accordance with Georgian customs legislation.

Additional information:

Heavy Cargo is above 150kg (+150) per 1 place.

– **Charges collect** settlement: Payment is paid at LASARE finance department instead of Air Company's finance office.

– **Cargo flights:** when using the standard service, the customer must submit relevant documentation 10 hours before the departure of the flight, and receiving the cargo and documentation submitting at least 10 hours before the departure of the flight.

_ **Passenger flights:** when using the standard service, the customer must submit relevant documentation 5 hours before the departure of the flight, and receiving of the cargo carried out no later than 24 hours before the flight departure. With expedited service, such as cargo pickup, the documents must be submitted at least 5 hours before the flight departure.

_ **Parameters of the truck:** – Volume 35 m³, load capacity 7900 kg.

For a lift one place **up to 1400 kg.**

_ **Parameters of the truck (with temperature mode):** – volume 27m³,
Load capacity 4900 kg. For a lift one place up to 1400 kg. temperature mode -2⁰-20⁰

_ **Parameters of the small size truck:** Load capacity 4300 kg.
One piece up to 1500 kg.

– Air cargo that due to its specification is not stored at the warehouse and is loaded directly to the consignee's vehicle is free of **storage charge**.

Tariffs are given in Georgian Lari (GEL) not including VAT.
